Providing **personal data** is voluntary, but necessary for membership. The controller of the data is the Association (details in the footer). They are collected to handle the membership and to record (to document) the activities of the association, including the achievements of its members, on the basis of the Polish Act of 7 April, 1989 – Law on Associations, and the General Data Protection Regulation 2016/679 (“GDPR”), ie. its Article 6 paragraph 1 point c (*legal obligations of the member; validity of resolutions*) and point f (*legitimate interests: names and faces of members in association’s activities has social significance, is a cultural and national heritage good, and a national archive resource*). The data will be stored not less than until the expiry of any possible mutual claims after the end of membership and the eventual liquidation of the association. Later they may stay a cultural property, national heritage and permanently stored archival materials. Membership data are not transferred to external recipients, but may be sent to supervisory authorities (including the court KRS and the mayor of Opole). Members have the right to request access to personal data, rectification and restriction of processing, and may have the right to erase it and object to processing.
